

MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING FOR THE MONTH OF JUNE' 2023

Date : 06-06-2023

Time : 11: 00 AM

Venue : Conference Hall (1st floor), Deputy Commissioner's Office, Sonitpur, Tezpur.

Members Present & Absent: As per List at ANNEXURE I.

The meeting was presided over by Sri Deba Kumar Mishra, ACS, Deputy Commissioner, Sonitpur, Tezpur. At the very outset, the District Development Commissioner, Sonitpur, Tezpur welcomed all the members present in the meeting.

The following matters were discussed in the meeting for further necessary action(s) to be taken up by the concerned department(s):

DOHUA:- Reg. Dev. Of Chowk Bazar project, the EE, DoHUA, Tezpur informed the Chair that the work will be started after completion of relocation of Chowk Bazar and expected to be completed by August'2023. The Chair instructed to expedite the work.

Reg:- the status of Integrated Sports Complex at Hazarapara, the EE, informed the house that the LOA has been received from the Chief Engineer and that the works associated with the PWD Deptt. are not in the position to commence..

Reg. Construction of Town Hall 1000 seater at Parua, survey and soil testing have been completed. There is however, the issue reg. encroachment of land.

Reg. the work in Junaki Pukhuri is 30% completed and boring works have started.

Reg. status of the work related to renovation, repairing and landscaping of DC Office, Sonitpur, Tezpur, the EE informed that revised DPR has been prepared incorporating Sewage Treatment Plant and is accordingly to be resubmitted.

LABOUR :- The Chair enquired about the Jagannath Skill Centre that is to be provided at the Tea Garden areas to which the Asstt. Labour Commissioner (ALC) informed about the issue reg. NOC approval and that a lot of TE has not yet provided land for the purpose of skill centre. The Chair herein instructed the ALC to communicate with the TE Manager and submit a report accordingly.

Meanwhile the Chair asked Inspector of Schools for A/C details to be provided for Tea Garden schools and liaise with the LDM as required in this regards.

The Chair instructed Inspector of Factories to inspect Tea Garden every month positively and also to provide presentation on inspection conducted and action taken report in the next DDC meeting. Furthermore, reg. matter related to licence renewal, the Chair instructed the Inspector of Factories to take the required approval from the Chair and provide intimation copy to the Chief Inspector of Factories.

The MIP, Sonitpur was instructed to conduct e-KYC meeting in all Tea Garden dist. under his jurisdiction and also to take special drive reg. AYUSHMAN BHARAT. When enquired about the vaccination/immunization drive by the Chair, the MIP informed that is has been conducted properly. Certificate has also been provided to the Pesticide Sprayers.

EXCISE:- The Supt. Of Excise informed the house that Rs. 16,34,64,957.40 revenue has been collected till date during the financial year 2023-24 for Sonitpur and Rs. 3,15,39,311.92 revenue has been collected till date during the financial year 2023-24 for Biswanath.

The Chair instructed to attach pictorials in the PPTs to be provided for the subsequent DDC meetings and that the pictorials of raid/seizure must be Geo-tag based.

TRANSPORT:- The DTO informed the house that during the financial year 2023-24, for the month

of April & May a total of Rs. 8,96,12,338.00 Revenue has been collected.

The Chair instructed the DTO, Sonitpur to liaise with the Executive Officer (EO), Tezpur Municipality Board about the e-rickshaw matter. Sri Pankaj Borah, ACS, ADC is to conduct meeting in this regards, if required.

PHE:- The EE, PHE informed the Chair that FHTC achievement percentage of Sonitpur district is 57.05% while that of State average is 50.08%.

The EE, PHE informed the Chair that 100% work of previously ordered Schools and AWCs have been completed for both divisions under JJM. The remaining schools and AWCs will be gradually covered under JJM pipe water supply scheme.

Reg. Jal Mitra Engagement, caretakers trained till last DDC meeting was 279 & engagement letters distributed was 331. The training for the 40nos Jalmitras are being carried on now. All Jalmitras who have received Engagement letters shall be trained in the ongoing and upcoming Training Sessions in ITI, Tezpur.

Schemes having Land Issues sanctioned in 2020-21 include:

- o Murhateteli PWSS(Gabharu Block)
- o Japisajia PWSS (Gabharu Block)
- o Parbatinagar PWSS (Gabharu Block)

and as such these schemes have been surrendered by Contractor.

The Chair instructed EE, PHE to consider additional Police Stations and Hospitals under JJM.

ANIMAL HUSBANDRY & VETERINARY:- The Dist. AH& Vety. Officer informed that under Artificial Insemination for the month of May'2023, 2106 nos. have been completed.

Also informed that under National Animal Disease Control Programe (fmd cp), Brucella Disease Vaccination-3800 doses(Round-II) and Swine Fever Vaccination 2427 doses have been provided.

Reg.: Storage facilities for Vaccines, the Chair instructed the Dist. AH & Vety. to bring the matter into the notice of APDCL for availing power connectivity. Herein, the Chair expressed displeasure about the absence of officials from the APDCL/ Power Department.

P & RD :- The Chair directed the CEO, SZP to conduct review meeting reg. all P&RD schemes on the 3rd Tuesday of every month in the presence of all BDOs of Sonitpur district.

PWD (ROADS):- The EE, Tezpur, Rangapara & Sootea TRD informed the Chair that all SOPD work are expected to be accomplish by August'23 ,with the overall progress being at 90%. Reg. RIDF (Rangapara) , Land issue problem is seen for which discussion with the concerned Hon'ble MLA has already been taken up.

POKIPATH works are gaining momentum.

The Chair directed EE, T,R&S to expedite the work of Parua & Besseria road.

The Chair enquired the EE, Borchalla & Dhekiajuli TRD reg. Plantation drive at Singri temple road and directed to furnish it within a day for a distance of 10 km approx. If needed, the community engagement for this particular work may also be engaged. In July on Van Mahotsav day has been considered as an appropriate day for its execution.

PWD (BUILDING) :- The EE, PWD (Building) informed the house that the construction of Balipara Degree College, physical progress is 95%, construction of Stadium at Bhutpura, physical Progress is 92%. And also informed the progress of various schemes under CIDF.

The Chair instructed EE to expedite the work related to construction of Stage at Darrang College and

hand it over to the authority at the earliest.

The Chair enquired about status of the construction work at Dist. Library and also enquired if the District Day which is to be held on 3rd August' 2023 can be hold in the District Library Auditorium, to which the EE replied about its uncertainty over its completion by July' 2023. The Chair instructed to expedite the works.

Reg. Construction work at Tezpur Medical College (Staff residence), will be completed by September'2023.

HANDLOOM & TEXTILES:- The Asstt. Director H & T informed the Chair that registration process under Swanirbhar Naari scheme will tentatively start from 1st June, 2023 onwards. In addition to Weavers, this next phase will cover registration of Entrepreneurs working in the Handloom sector as well.

In Sonitpur Dist. Total nos. of Entrepreneurs registered is 60 nos.(where 514 nos. are Weavers).

HEALTH :- The Chair asked about the NAQS targeted facility . Again the Chair enquired all HODs about NI-KSHAY MITRA adoption and directed that registration of it must be of per person/patients basis.

FOREST:- The DFO informed the Chair that still some of the departments have not cleared their pending Forest Royalty.

AGRICULTURE :- The DAO, Sonitpur , Tezpur informed the Chair about Assam Millet Mission, Crop condition is good , at present, at harvesting stage , Expected production is 20Qt/Ha. Within June, 2023, three schools and three farmer crops are to be selected for awareness creation under Assam Millet Scheme.

The DAO also informed that no Urea Crisis is witnessed till date.

The Chair instructed DAO that Gejenjuli and Barchalla have to be considered for establishment of Godown.

FISHERY :- The Chair enquired DFDO, Sonitpur ,Tezpur about the status of turtle shifting (Junaki pukhuri) on which he informed the Chair that after consulting it with the DFO, Sonitpur , turtles are now released at the Cole Park.

DI&CC :- The Chair discussed with the GM, DI&CC reg. Land availability for establishment of industries.

Again the Chair instructed LDM to work into various proposals under PMFME in respect of Sonitpur dist.

LEGAL METEROLOGY :- The Asst. Controller informed the house that Rs. 2,86,775.00 revenue has been collected during the month of May'2023.

Also informed that a total of 11 nos. of cases has been detected in the month of May'2023.

SOCIAL WELFARE :- Reg. One stop Centre the Chair instructed Smti. Barsha Talukdar, Asstt. Commissioner to send a proposal for the same.

SOIL CONSEVATION :- The Chair instructed the Divisional Officer, Sonitpur Soil Division to provide the list of names of all Clerical Staffs who have completed 5 years of service.

The Chair instructed that only the eligible beneficiaries under the Livelihood Mission Scheme be selected. Proper selection procedures be followed herein.

The scheme under RIDF near Dikrom River is expected to be completed around mid-June, 2023 as informed by the Divisional Officer.

MISCELLANEOUS :-

- The Chair instructed all HODs to submit the draft PPT presentation containing format for district profile and various schemes reg. Hon'ble Governor visit to Sonitpur District.
- The ADC, Biswanath and the SDO, (Civil),Gohpur should be invited in the DDC Meetings from next month onwards.
- EE, PWD(NH), Nagaon and EE, PWD(NH), Rangia Division should be invited in the DDC Meetings from next month onwards.
- The Chair alerted all HODs to be prepared for flood precautionary measures.

The meeting ended with a vote of thanks from the Chair.
