## NOTICE INVITING TENDER

Sealed quotation affixing court fee stamps amounting to Rs. 8.25 (Rupees Eight & Twenty-five paisa) only are hereby invited from intending offset printing press for printing of Photo Electoral Roll (PERs) of Tezpur Election District subject to the following terms and conditions and will be received by Election Officer, Tezpur up to 3.00 P.M. of 28/10/2024 at his Office chamber and will open the quotation on Same day at 03.30 P.M. in the presence of quotationer/ their authorized representative who may remain present at that time. In case quotationer are absent at the opening of the tenders, the undersigned will reserve the right to open and finalize the tenders in their absence.

1. The offset printing press must be registered by the Printing & Stationery Dept., Govt. of Assam and must have sufficient manpower and machinery to meet emergent need.

2. Rates should be inclusive all Taxes but exclusive of GST. The rates of printing should be inclusive of the cost of papers also (i.e. cost of printing with paper).

3. The Rates of printing of PER should be in both size of A4 size paper 75 GSM (inclusive of paper cost & Taxes), should not be above Rs. 2.80 and in case of single side of A4 size paper of 75 GSM (inclusive of paper cost and taxes) should not be above Rs. 1.80.

4. In case of printing error the respective press will be responsible and shall have to bear the cost of printing.

5. This Office gives no assurance to the 1-1 bidder to award the work at his quoted rate. If the undersigned finds that the L-1 rate is on the higher side, the undersigned may negotiate the price with L-1 bidder at the rate deemed appropriate.

6. The authority is not bound to issue order to the successful bidder.

Tax clearance, GST Registration Certificate, PAN Card, Earnest Money of Rs. 1000/- (One Thousand) only must be submitted along with quotation.

8. Payment of bill will be made as per Assam Govt, rules on receipt of fund through budget allotment from time to time. The undersigned will not be responsible for any delay in payment of bill for reasons beyond his control/authority.
