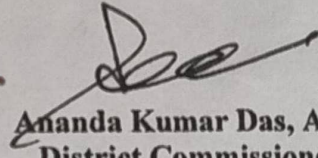

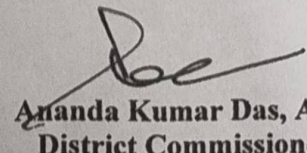
The Order comes in force with immediate effect.
