

**MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING**  
**FOR THE MONTH OF MAY, 2022.**

**Date** : 05-05-2022  
**Time** : 11:00 AM  
**Venue** : DC's Conference Hall, Sonitpur, Tezpur.

Members present & absent: As per List at **Annexure I.**

The meeting was presided over by Smti Romy Baruah, ACS, Deputy Commissioner, i/c, Sonitpur, Tezpur. At the very outset, the Chair welcomed all the members present in the meeting and instructed the Heads of Department to comply with the Chief Minister's Actionable & Monitorable Targets and ensure their completion before deadline. She also informed the House that to counter any natural disaster during upcoming Flood Season a Grievance Cell has been opened and all concerned departments are to liaise with DDMA and submit status report.

The following matters were discussed in the meeting for further necessary action(s) to be taken up by the concerned department:

**DISTRICT SOCIAL WELFARE:**

Smti. Kabita Phangso, ACS, i/c Social Welfare Officer, Sonitpur briefed regarding the ongoing schemes of Social Welfare undertaken in Sonitpur district. Out of 51 Nos. of building construction of Model Anganwadi Centres 50% works were completed. As the target for completion of all AWCs has been fixed on 30/05/2022, all the works to be completed by 25-05-2022. One signature project- Building construction Home for children with 100 children capacity going on at Rowmari, Chariduar. For inclusion of more beneficiaries under Deendayal Divyang Pension Awareness Camps are to be held every week. Hot Cooked meal for poor normal children from age group 3 years to 6 years are being provided regularly. The Chairperson instructed the i/c Social Welfare Officer to conduct inspections. Regarding promotional matter of Anganwadi Helpers to Anganwadi Workers the matter is pending with the Selection Committee

**EXCISE:**

The Supdt. of Excise informed that the annual collection was Rs.84.5 crore out of target Rs.112.00 crore last year. The target could not be achieved due to Covid-19 pandemic. The Chair asked to conduct regular raids for seizing Arunachali liquor entering the region.

**POWER:**

The AGM, APDCL stated regarding the line shifting matter with NHIDCL that expenditure estimate has already been submitted to Chief General Manager, APDCL approval awaited. Under Saubhagya scheme the beneficiaries received subsidy upto April'2022. They were informed regarding payment of electricity bill from May'2022 onwards. Agreement has been made with beneficiary consumers. On the question of fitting LED bulbs in every AWCs and Schools the AGM told that there is no scheme for free distribution of LED bulbs in AWCs & Schools. If fund is made available then bulk purchase of LED bulbs can be made at cheaper price. Electrification of AWCs to be done by 10/05/2022. Out of 616 numbers of Solar electrification 322 numbers done where normal electrification couldnot be done. Remaining numbers would be completed by 30/05/2022. The AGM requested DFO to denude some trees in forest area for construction of electric transmission lines. Accordingly, DFO requested the AGM to submit the list of such areas so that action could be taken.

**EDUCATION:**

The Inspector of Schools, Sonitpur informed that the PWD building has completed and handed over 7 (Seven) numbers of model school buildings out of 10 (Ten) numbers the EE, PWD building(B) was directed to out of 3 (Three) left 1 (one) to be completed by 10/05/2022 and 2 (Two) numbers to be completed in the month of May'2022. Regarding Bala painting the IS told that it will be completed in all 10 (Ten) numbers school by 10/05/2022. As per earlier Minutes it was directed to submit requirement of LED bulbs in AWCs and schools to APDCL by 08/05/2022. Regarding plantation of saplings the IS told that he has already instructed the in charge of all schools to collect saplings from designated forest office as per advice of DFO. DFO to start distribution from 07/05/2022. The Chair asked the DFO and IS to coordinate. Regarding construction of science laboratory in schools only 80% work is completed, the matter is pending since 2015-16. The Chair asked to ADC (Edu) to look in to the matter and take necessary action.

**PWD (BUILDING):**

The EE told that the building construction of ITI is at halt due to dispute with army. The work associated with the construction of medical college is only 48% completed due to delay in received of plan & estimate and removal of underground electric cable. Completion target set on April'2022 is now extended and expected to be over by December'2022. Construction of ICU at Paruwa-100% completed ancillary works to be completed by May'2022. Construction of building at NERIWALM to be completed by June'2022. Construction of girls hostel at tezpur under Untied fund to be completed by December'2022. The construction of Govt. Low college Sootea to completed by June'2023. Construction of polytechnic building 100% completed. Addl. Estimate send to Govt. as per requirement of the Principal. The EE told that the construction of ITI Building at Rangapara and Baan Theatre, Tezpur have not yet been completed. Construction of Barachahariya Bhauna at Sootea to be completed by Dec.'2022. Computer Building at Darrang College to be completed by June'2022. Model Degree College at Balipara to be completed by December'2022.

**DOHUA** :- Regarding construction of Swimming Pool at Hazarapara Stadium the Executive Engineer told that the Scheme already exists in the Master Plan. The Sports Officer told that they have already submitted proposal to Government. In the matter of Construction of Chowk Bazar under CIDF rehabilitation of about 500 Shops will be required and a meeting with TMB and District Authority will be held shortly.

**AGRICULTURE:** The DAO informed the Chairperson that a Meeting on fertilizers will be held on 06-05-2022. The Chairperson asked the DAO and Deputy Director F&CS to coordinate in the matter of procurement of Paddy from every registered Farmers.

**AGRICULTURE (Eng):-** The EE informed the Chairperson that a DLSC Meeting for selection of beneficiaries for Solar Irrigation will be held shortly.

**IRRIGATION:-** In the matter of functioning of Solar Irrigation at KVK, Tezpur, which was installed in the year 2021, the EE informed that due to Cable theft in the above Irrigation facility inside the KVK boundary the facility is lying defunct. An Estimate of Rs.2.00 Lakhs will be required for repairing. The matter has been informed to the Govt. however approval is awaited. Regarding Bordikarai FIS a joint survey was instructed, but date not yet fixed, which will be done shortly after discussion with CEO, SZP. Under PMKSY all 423 pin points works completed by 31-01-2022. Minor repairing works were ongoing. Proposals under Har Khet Ko Pani Phase-III for small Tea Growers have been sent to Govt. Works of Sopai Baligaon FIS ongoing. Works of Panbari FIS to be completed by 15-05-2022.

**FOOD & CIVIL SUPPLIES:** The DDS&CA informed the house that 78% of ADHAAR seeding of Ration Card has been completed and ADHAAR seeding in Tea Garden areas is less due to less number of AADHAR Enrollment in Tea Garden Areas.

**AH&Vety:-** The Veterinary Officer informed that 61000 Nos. vaccines have been received, Target to be completed by June, 2022. Artificial insemination done for 3290 cows. Calf born 1490 Nos.

**T&CP:-** The Dy. Director informed that the works for Car parking facility at Convention Centre, Batamari is ongoing which will be completed shortly.

**PHE:-** The EE informed that all leftout Water Tap connections under JJ Schemes will be completed within next 15 days.

**LEGAL METROLOGY:-** The Legal Metrology Officer informed the house that during inspection at Hotel Madhuban, a food safety lapse was detected for which a Case was registered against Hotel Madhuban for Food Safety Violation which has been sent to the Govt.. A Case was also registered against Vishal Megamart due to manipulation of price tag by pasting higher MRP Sticker over the actual manufacture printed price in some commodities.

**SOIL CONSERVATION:-** The EE informed that the construction of Division Office to be completed by March'2023.

**FISHERY:-** Proposals were being under taken under AMRIT SAROVAR SCHEME.

**DICC:-** The GM, DICC informed that under PMEGP last year target achieved 100% fully. In the Current year applications received are 29 Nos. and till date 7 Nos. were sanctioned. He also informed that a new Scheme has been launched by the Govt. namely – PRIME MINISTER FORMALIZATION OF MICRO FOOD PROCESSING ENTERPRISE and steps are being taken for imparting of training.

**HANDLOOM & TEXTILE:-** The Asst. Director, told that under Mudra Loan Scheme 117 Nos. Loan Proposals were submitted to concerned Banks and is under process at the banks. The Chairperson told the Asst. Director to hand over copy of a list of beneficiaries to the LDM.

**SPORTS:-** The Sports Officer informed that under CMSGUY the field development works are undergoing at Chariduar and is 80% completed. At Bishnu Rava Memorial school & Sonajuli Memorial school 80% works completed. He further informed that as per plan the Deputy Commissioner is to organize Volley ball competition at District Level and at district headquarter from among the qualified players of Block Level sports competition.

The meeting ended with a vote of thanks from the Chair.
